Provisions from these instruments state that human rights education consists of efforts to build a universal culture of human rights through the imparting of knowledge and skills and the moulding of attitudes such education be directed towards:

- Strengthening respect for human rights and fundamental freedoms;
- Fully developing the human personality and its sense of dignity;
- Promoting understanding, tolerance, gender equality and friendship among all nations, indigenous people and racial, national, ethnic, religious and linguistic groups;
- · Enabling everyone to participate effectively in a free society and-Furthering United Nations activities for maintaining peace.

Objectives of Human Rights Education:

A growing consensus holds that human rights education can both help reduce human rights violations and contribute to building free, just peaceful societies. Human rights, as inscribed in the Universal Declarations, from the common language of humanity.

The objectives of the nations in its human rights educational efforts are to teach the common language of humanity to people everywhere.
