#### 2. Airline bankruptcy after covid pandemic emergence

## • Virgin Atlantic and Virgin Australia

Virgin Atlantic joined the fray in August 2020, filing for Chapter 15 bankruptcy as it worked to firm up a bailout aided by the British government. Its sister airline, Virgin Australia, had already filed for bankruptcy in April after the Australian government decided against a massive bailout. Delta owns 49% of Virgin Atlantic.

## Norwegian Air

Norwegian Air was already struggling before the pandemic, and several of its subsidiaries had already filed for bankruptcy. But it joined them officially in November 2020, filing for what amounted to a Chapter 11 equivalent in Ireland, and then the same in Norway in December. The low-fare carrier said it would operate normally while trying to restructure. After six months, the airline emerged from bankruptcy in late May, announcing it had nearly wiped out its debt with 6 billion Norwegian crowns (about \$716 million) in fresh capital and plans to revamp itself as a regional carrier with a leaner fleet of planes.

#### Aviance

This prominent Latin American airline filed for Chapter 11 protection in May 2020, blaming "the unforeseeable impact" of the pandemic on business. The company cited travel lockdowns, but analysts said the airline was already in trouble from negative credit ratings and sudden leadership changes.

## • LATAM Airlines

Latin America's largest carrier filed for Chapter 11 protection in May 2020. Unlike chief competitor Avianca, it was on solid financial footing before most flights were grounded, according to Reuters.

## • Compass Airlines (US)

March 2020, Compass Airlines — also owned by Trans States Holdings — will also shut down in April. Compass is another regional carrier, which operates flights for American Airlines under its American Eagle brand. With American cutting domestic capacity by up to 80% by May, it's had less of a need for contract airlines.

#### • Trans States Airlines (US)

March 2020, Trans States Airlines is a Missouri-based regional airline that flies routes for United under the United Express brand. The airline had already been planning to shut down by the end of 2020, consolidating its operations with ExpressJet Airlines, another of United's regional carrier. However, due to

the "unforeseen impact of the coronavirus," the airline will cease all operations on April 1, Trans States Holding CEO said in a memo to employees. Trans States operated a flight of Embraer ERJ-145 regional jets.

## • Flybe (UK)

March 2020, UK regional airline Flybe entered administration — a practice similar to declaring bankruptcy — on Thursday, March 5. Although Flybe was already on the brink of collapse — despite a major investment by a Virgin Atlantic-led consortium the previous summer — the coronavirus crisis pushed it over the edge. Flybe operated about 40% of domestic flights in the UK.

## 3. Factors causing airline bankruptcy

#### • Passenger behaviour

As the pandemic start to spread, passengers avoid travelling to safeguard themselves.

#### • Suspension of flight operations

After the emergence of the covid spread, most of the country's government impose suspension of airline operations as a control measure of pandemic spread. It affects the functioning of airline business vastly.

#### • Long lasted shutdown of airline activities

After a year, most of the developing countries and under developed countries loosen their restrictions on airline operations. But developed countries and some developing countries didn't impose any relaxation on their restrictions on airline operations. It caused a serious effect on the survival of the airline sector.

#### Hotels

## Bars & Cafés

## 4.4 Entertainment

#### • Casino

#### • Shopping

#### • Tourist Guides & Tours

#### 4.5 Connected Industries

#### Tour Operators

A tour operator will typically provide travellers with package holiday products, which combine travel and tour components.

## • Online Travel Agencies (OTAs)

Online travel agencies, or OTAs, provide similar services to traditional travel agents, albeit through a website or web app. One of the key differences between OTAs and classic travel agents, however, is the emphasis that OTAs place on self-service, with the website or app connecting users with the travel products they are looking for.

## • Tourism Organisations

Tourism organisations are organisations that are actively involved in promoting the tourism industry and its interests.
