But an elite spoiled brat frames Stephan into a bank robbery of which he, himself was a perpetrator. Stephan dies tragically at the end of the story tired of being exploited by elites. The COVID-19 crisis delineated the same exploitation of poor working-class people who lost their lives at the hands of elites. Wealthy travelers brought the disease into poor countries bringing death to thousands of poor people having bad sanitation facilities. Friedrich Engels once pointed out that

The above statement itself unleashes the lives of the poor and the migrant workers of all countries including India who are facing unimaginable difficulties and becoming victims of the COVID-19 pandemic. And the piteous fact is, even if the vaccine gets produced, it would still be unapproachable to the poor because of its extortionate prices.

They were being treated merely because they had turned into carriers who could spread the disease and could cause the country and its economy a great loss. It reminds me of Anthony Burgess's novel The Clockwork Orange, another dystopian fiction that represents the current vicious generation that seems to be programmed to do evil.

The novel begins with a 15-year-old boy, Alex, who finds a thrill in tormenting other people around him. One day on his way home, Alex with his friends assault a scholar, and rob a store leaving the owner and his wife bloodied and unconscious. They beat up a beggar, stole a car, starts their ride to the countryside, and break into a cottage where they terrorise a young man and rape his wife. The fictional generation in the novel doesn't seem to be alien to the current generation where Corona patients don't hesitate even to molest the nurses who are sacrificing their lives in order to treat them.

So, I believe that it would be an injustice to blame COVID-19 solely, for the abominable condition as the pandemic is only one among the results of our vicious activities.
