Many efforts have been made to address the resulting marginalization of women's rights, including the adoption of the Convention on the Elimination of All Forms of Discrimination against Women (CEDAW) and the mainstreaming of women's human rights. While these efforts have been successful in many ways, conceptual and practical problems remain, including not only the limitations of anti-discrimination law, but also the danger that concrete recognition of women's rights violations may simply reproduce women's secondary status.
