For example, in *chikitsasthana* while explaining *Gulma chikitsa* (chapter 5, *shloka* number 63-64), *Prameha pidika* (chapter 6, *Shoka* number. 57), *Udara chikitsa* (chapter 13, *shloka* number. 184-186), *Arsha chikitsa* (Chapter 14, *shloka* number. 34), etc. stated that preference should be given to *Shalaya chikitsak* of *Dhanwantari sampradaya*. These references highlight the long-standing tradition of integrating various medical disciplines to achieve the best outcomes for patients, with a particular emphasis on referring to or consulting with specialists when necessary.

Evidence of successful integration - Numerous studies have demonstrated that integrating complementary therapies into conventional care had improved symptoms, reduced side effects of treatments, and enhanced quality of life of patients. 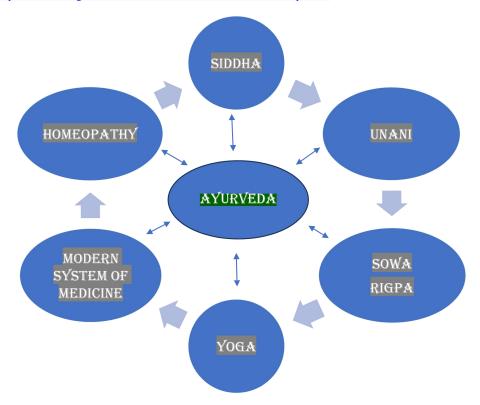


Figure 1 - Integration of medical sciences.
