Kidney stones are solid masses comprised of crystals known as Nephrolithiasis^[1] It is an increasing urological disorder of human health, affecting about 12% of the world population. It has been associated with an increased risk of end-stage renal failure.

Case summary- A 25 years old lady was coming in our OPD suffering with pain in lumbo-sacral region since 7-8 days. Specially Right side. The patient was treated with homoeopathic medicines -Berberis vulgaris Q. Follow-up imaging at 2 months showed complete resolution of the nephrolithiasis. This case report highlights the importance of homoeopathic mother tincture prescription as a promising complementary or alternative therapy.

The term Nephrolithiasis denotes the development of calculi or stones in the kidneys or urinary tract which may be single, numerous or complex. Stones can develop in the bladder, kidney or pelvis. It is made up primarily of organic material around which the urine salts are dispersed. Kidney stone are becoming most common throughout India but are especially prevalent in Gujarat, Rajasthan, Punjab and Madhya Pradesh. A urinary tract stone affects about 2% of the community on average, while the actual incidence and prevalence have not been determined.

Urinary lithiasis patients rarely feel comfortable in any position. Fever is not present unless a urinary infection also coexists with the calculus but they constantly move about in an effort to "shake off" whatever is making them uncomfortable. Pain and agitation may induce an increase in heart rate and blood pressure. [4]

- A moderate amount of deep discomfort can be felt while palpating the calculus
- and the loin area of the abdomen.
- Pain in the back side and area below the ribs. Fluctuations in pain severity with

intervals of discomfort lasting 20 to 60 minutes are typical. This pain often

exclusively affects the side of the nephrolithiasis.

- Lower abdominal and groine pain that radiates from the side and back.
- \bullet Bloody, murky or foul-smelling urine.
- · Pain, swelling and discomfort after urinating.
- · Nausea and vomiting.
- · A persistent urge to urinate.
- If an infection is present, fever and chills.



- 1) A 25 years old lady was coming in our OPD suffering with pain in lumbo-sacral region since 7-8 days. Specially Right side.
- 2) Character of pain –Sharp cutting type.
- 3) Burning after urination.
- 4) Painful and frequent urination.
- 5) Backache since 1 month.
- 6) She feels tiredness and weakness.
- 7) Nausea sensation.

History of presenting complaint: Patient was apparently well 7-8 days back when she had gradually complaints of pain in lumbo-sacral region. Weakness feeling. Pain is irregular type. Burning and painful urination. She took allopathic medicine for temporary relieve.

Past- history: Renal calculi Right side 2.6 mm calculi (2019) Taken Ayurvedic Treatment and allopathic medicines.

Mental-generals:

- Anger ++.she screams angrily and throw things.
- Introvert
- · Desire open air
- Consolation aggravation
- Fear of darkness

Physical Generals:

- Appetite Diminished, (2 chapattis in day time & 1 chapatti in night or patient sometimes skip the meal) prefer warm food.
- Thirst-Decreased 2-3 glass of water / Day, SQLI.
- Desire Salty++, sweet
- Aversion Green chilly
- Stool–Regular, unsatisfactory 2-3 times daily, semi solid consistency.
- Urine-D5-6; N-3-4. Dark yellow colour urine, no odour, painful urination, burning after urination & frequent urination.
- Perspiration-Profuse specially on face. No staining & No odour.
- Sleep/ dreams 6-7 hrs unrefreshing sleep dullness sensation
- Addiction
 – Smoking since 5 years; 2-3 cigrattes/Day & occasionally drink

General Management


- Drink plenty of fluid: 3-4 liter/day.

- · Avoid smoking.



USS Score Before and After Treatment:


