## **Determine the Factors to Preserve the Curative Powers of Homoeopathic Medicines**

### **ABSTRACT:**

Drug testing is a systematic investigation of the pathogenetic (disease-causing) power of medicine (and thus also the curative power) in healthy people of different ages, both sexes, and of different composition. Many people have the idea that there are no side effects from using homeopathic remedies. But if homeopathy is used either more than individually or in large quantities without following the principles, then the medicine begins to prove itself in the individual and creates an artificial disease, which, according to the founder of homeopathy, Samuel Hahnemann, is very difficult to treat in his book *Organon of Medicine*, as well as found in practical life.

Homeopathic dynamization is a process in which the healing properties latent in natural substances in their raw state are awakened and developed to an incredible extent. Medicines are potentiated in two ways.

### **INTRODUCTION:**

Devotees of homeopathy have been trying since ancient times to preserve homeopathic medicines and healing power for beneficial effect on mankind. Nowadays, we also need to find some other factors that can preserve the healing properties of homeopathy in order to fulfill the mission of our Master Hahnemann.

Since the drugs are capable of producing similar symptoms, there was one problem with their use. They caused a serious increase or worsening of the disease during treatment, because the symptoms of the disease were added to those caused by the drugs! Dr. So Hahnemann tried to dilute the drugs to minimize these side effects. During these experiments, he made the crucial observation that "the more the medicinal substance is diluted and shaken, the greater will be its therapeutic effect." Provided you are doing it the system method! After refining it, he called this process potentiation or dynamization. It is a process of serially diluting the raw drug in a neutral liquid (alcohol/water), adding more and more liquid, and shaking in a specific way at each stage. According to him, homeopathic dynamization is a process that awakens healing properties that are latent in natural substances (in their raw state) and then allows them to act in an almost spiritual way on our life principle. The product of dynamization is called potency. The amazing fact is that when drugs are potentiated in this way, their medicinal properties increase in geometric progression as they are diluted! The higher potencies (actually more diluted!) are used with extreme caution in the system and are capable of greater penetration and are particularly useful in the treatment of long-standing chronic cases.

During his earlier period, Hahnemann used massive doses, as was customary at the time. But by his keen observation he was able to discover that large doses of the drug caused undue agitation. In § 621 in *Lesser's Writings (On the Nature and Treatment of Venereal Diseases)* 1786 (p. 133) he says: "... in very sensitive persons I have never had occasion to use more than 1 grain of soluble mercury to cure moderate idiopathic venereal symptoms and incipient syphilis, yet I have met with cases where 60 grains were required".

He says that he was forced to use so much medicine because some of the patient's circumstances had to be interrupted by the medicine. Hahnemann says that not more than 8 grains were needed in moderate syphilis, while about 12 grains were needed in severe and deep-seated cases.

After the first dose, Hahnemann gradually increased the dose until the disease disappeared.

In the *Minor Writings* he tells the method of increasing the dose in a progressive scale from  $\frac{1}{4}$  to  $\frac{1}{3}$ ,  $\frac{1}{2}$ ,  $\frac{3}{4}$ ,  $1\frac{1}{4}$  grains, then after an interval of 14 days increasing the dose again from  $1\frac{1}{2}$  to 2 grains until the syphilis disappeared.

Here we can see that Hahnemann deduced that a large amount of medicine was not the factor that helped to cure the disease, but only a sufficient amount was needed to cause a reaction. Hahnemann thus reduced the large amount of mercury given to treat venereal diseases to just enough to cause mercury fever. Hahnemann thus reduced the quantity of mercury required for the treatment of venereal diseases from 12 grains, 5 grains, etc., to 11/2 to 2 grains.

Although Hahnemann practiced a crude form of succession and trituration from 1801, later in 1833 he established rules and procedures for the preparation of homeopathic potencies. Thus, Hahnemann's centesimal potency scales were born. This led to standardization in the preparation of potencies.

Although Hahnemann presents the theory of dynamization by trituration and succession in the 5th edition of the organon, i.e. (1833), this idea was already hinted at in 1829 in the final sentence of the second note to § 278 of the fourth edition. This was stated more explicitly in 1826 in a note on Thuja (M. Mpura ii 649) which reads as follows: "The discovery that crude medicinal substances (dry and liquid) develop their healing power more and more by trituration or following non-medicinal matter and to a greater extent, the further, the longer, and the more strongly this trituration or succession is carried out, so that all their material substance seems to be gradually dissolved and dissolved into the pure healing spirit".

§287 fn. Hahnemann says that the higher we carry the depression accompanied by dynamization (two successive strokes) with a much quicker and more penetrating action, the preparation seems to affect the vital force and change the health, but with a slight diminution of power, even when this operation is finished. carried very far - in place, as usual (and generally sufficient) to X, when carried to XX, L, C and above, only then the action always seems to take less time.

## REVIEW OF LITERATURE:

When making medicines from plants, the exact species must be carefully determined and it is important to find the most perfect specimens of the species available. Plants should be collected in optimal conditions and should grow in their natural environment. They should be harvested when the part of the plant to be used is at its best, which is usually spring or summer. Plants must grow away from polluting factors such as pesticides or artificial fertilizers washed off from surrounding fields. Sadly, with so much polluted air and water these days, it is difficult to ensure that contamination does not occur. But on the positive side, the fact that traces of some pollutants can be in the tinctures used for treatment can actually help people fight the effects of environmental pollution that is now a part of our daily lives.

### Trituration

The energetic properties of many minerals and other chemicals and even some plant products cannot be prepared for potentiation by making tinctures because the materials are insoluble. The way they are prepared varies with each substance, but commonly the process involves what is called trituration: that is, crushing the substance with a set amount of milk sugar using a sterile pestle and mortar for three hours. Milk sugar, also called lactose, is used as a medium because of its neutral properties. This process reduces the drug to a millionth dilution, also called 6x or 3C potency. At this level, the substance is soluble in alcohol.

### Dilution and suction

There are two different ways to do each dilution before pressing. Hahnemann's method consists in taking one drop of the previous potency and diluting it with alcohol or double-distilled water in a specified proportion. That is then blended. A fresh sterile bottle is used to prepare the next potency.

In the Korsakoff method, after aspirating the first potion, the contents of the vial are poured, either into another sterile container, if the potion is to be kept, or into the waste, if it is to be thrown away. One drop of the medicine will remain stuck to the wall of the bottle. Then fresh alcohol or distilled water of 9, 99 or 49,999 drops is added according to the scale used. In this method, the same vessel is used for the production of each potency, except that a fresh sterile vial is removed from time to time to prevent contamination from the atmosphere. In the Korsakoff method, 4, 6, or 8 vials can be used to make 30 or 200 potencies, while in the Hahnemann method, 30 or 200 vials are needed.

Hahnemann used pure alcohol with each new potency. This meant that tens of gallons of alcohol were needed to achieve high efficiency. In practice, this is very expensive, especially if the pharmacist uses the Hahnemann method of dilution each time with a new vial. So today many pharmacies use doubly distilled water for medium potencies and alcohol only for those they keep. Many of the dilutions are not used because experience has shown that certain potencies are most effective.

There is some disagreement about the validity of Korsakoff's method, but since there is no difference in the dilution ratio at each stage, there seems no scientific reason to doubt it.

### Succession

Suction or violent shaking was originally done by hand. Today, much of it is done by machine, but even with mechanical aids, it can take up to 10 or 12 weeks to prepare a tincture of the highest potency. In the nineteenth century, this time element led to the work of preparing some of these potencies being left to people like lighthouse keepers who had long, lonely hours on duty with only their light to tend to. The rhythmic, carefully repeated motions required in trituration and suction helped to keep them awake while benefiting homeopathy.

Each indentation should be equivalent to the force exerted by an average healthy man when striking a hand-held vial (a tightly closed test tube or other laboratory container) against a solid surface. Hahnemann used a large book bound in leather. With each push, the vial stopped briefly, inertia causing the liquid in the vial to jump. Today's machines mimic this action, but need careful regulation and frequent maintenance to ensure that suction is standardized.

## Potency

Homeopathic potencies show the strength of medicines. The more the medicine is diluted, the more effective it is. Efficiencies are measured according to two basic dilution scales – decimal and centesimal. In the decimal scale, the potency is diluted tenfold each time. Such potencies are indicated in Britain and America by the number for the potency followed by the letter x (the letter D is used in continental Europe); for example 6x or 6D. On the centesimal scale, the potency is diluted 100 times each time. Such potencies are indicated by a potency number followed by the letter C in Britain and America (CH in continental Europe); for example 6C or 6CH.

Medicines can be prepared for use in the form of tinctures (alcoholic liquids), pills, tablets, triturations, granules or powders. Whatever form is used, it is indicated by potency either on the decimal or centesimal scale, more rarely by the Greek letter phi denoting the mother tincture.

Hahnemann said that the method used in the preparation of the various potencies played an important role in releasing the energetic quality of the substances used. From the initial mother tincture or trituration, one drop or grain is diluted or triturated with 9 or 99 or 49,999 drops or grains of alcohol or lactose, the resulting dilution being assayed in a specific manner from 40 to 100 times, whichever the apothecary chooses. This succussion makes the first decimal, the first centesimal, or the first millesimal power.

The potency scale preferred by Hahnemann and many other homeopaths who carefully follow his teachings is the centesimal. Each centesimal potency is equivalent in dilution to two decimal potencies; in other words the 30C potency is the same dilution as 60x. However, 60x will have twice as many kills and is therefore considered a higher potency. It is the suction process that releases the dynamic energy of each dilution into the solvent.

The millesimal (LM) scale, diluting the drug by 1 part in 49,999 for each potency, was developed by Hahnemann towards the end of his life. However, this was not known until the discovery of the sixth edition of Hahnemann's *Organon* in this century, which was then translated and published in the United States in 1921 by Dr William Boericke, the first Professor of Homeopathic Materia Medica and Therapeutics at the University of California.

From clinical experience, practitioners have found that different potency scales seem to be more effective for certain conditions than others. Different potencies in each range may suit some patients or their conditions better than others.

The harmonic progression of potencies that Hahnemann used was 3C, 6C, 9C, 12C, 15C, 18C, etc. This progression seems to be particularly effective in treating people suffering from severe chronic physical diseases who have low vitality. In severe acute conditions, when the vital force is good and the indications clear, the high potencies seem to work best. However, this is not always true, as a recent research project showed, despite being statistically poorly analyzed. Bruises were shown to respond better to the higher dilution of *Arnica montana* 10M (1000C) than to the lower dilution of 30C.

## Homeopathic vehicles

The term 'vehicle' implies, "Means of transport or transmission", In homeopathy, a vehicle is a substance in which medicines are prepared or mixed and administered for their internal administration either by oral or olfactory method and external application for medicines. These substances are comparatively inert as such gases as a means of developing the therapeutic activity of the medicinal substance.

### THE IDEAL VEHICLE

- I. It must have no medicinal properties of its own.
2. It should be chemically neutral; neither acidic nor basic in medicinal effects. It must not be subject to change or decomposition,
- 3, The above two specific properties are more applicable to those used in potentiating drugs.
4. It must be harmless in terms of its effect on human organisms. The pharmacological message of the original drug is not disturbed in any way.
- 5 He should be able to transfer the dynamic powers of drugs into the inner human organisms to fight the power of disease.
6. It should be edible and tasty.

Use of vehicles:

1. Vehicles are used in the preparation of mother tinctures, mother solutions and mother powders from raw medicinal substances and without any vehicles this preparation could not be made.
2. It is used for additional trituration and increased potency from the mother, so that the pharmaceutical message is easily transferred and the therapeutic values of the individual medicinal substances are preserved.
- 3 It is used as a basis for the preparation of external drug applications.
4. To dispense medicines or remedies as prescribed by doctors.
5. Vehicles such as olive oil, petroleum jelly, glycerin, etc. are applied externally only as a mechanical aid.
6. As a preservative or certain medicines, a vehicle such as alcohol is mixed in a certain percentage with the freshly pressed juices of plants (see *Organon of Medicine*, aphorism 268, footnote).

7. It is used as a "placebo" or "phytum" between the administration of two doses of drugs or medicines, especially in cases of chronic diseases and where long-acting drugs are used. Dr. Kent claims that "The second best medicine in our MateriaMedica is the placebo," which is administered to the patient for pleasure.

8. Sick children who cannot tolerate fats are given milk sugar as a diet.

Forms of vehicles

There are two forms of vehicles: 1. Solid and 2. Liquid.

Fixed vehicles:

1. Milk sugar or milk sugar (saccharum Lactis, Lactose).

2. Globules or pills.

3. Pellets.

4. Tablets or tabloids.

5. Pine cones.

Liquid vehicles

1. Aqua Distillata (distilled water)

2. Alcohol – absolute alcohol, strong alcohol, dispensing alcohol, diluted alcohol

3. Glycerin

4. Olive oil

5. Almond oil

### **DYNAMICS OR DYNAMIC PERFORMANCE**

Dynamic action or force is the action of one substance upon another without discerning a reasonable connection between cause and effect.

Hahnemann calls such effects dynamic, virtual, that is, those that are the result of absolute, specific, pure energy and the action of one substance on another substance.

\*\*\* The earth carries the moon round her in an orbit in twenty-eight days and several hours, and the moon alternately, at certain fixed hours, raises the sea to high tide, and lowers it again correspondingly to low tide. This is not done through material agents, not through mechanical devices such as are used for the products of human labor.

\*\*\* Similarly, the energy of a magnet attracting a piece of iron or steel needle is not material, it is not mechanical. One can see that a piece of iron is attracted to one pole of a magnet, but one cannot see how this happens. The steel needle itself becomes magnetic, even at a distance where the magnet does not touch it, and magnetizes other steel needles with the same magnetic property (dynamically) that the magnetic rod had previously endowed it with.

In the same way, the dynamic action of disease-causing influences on a healthy person, just like the dynamic energy of medicines on the life principle in the restoration of health, is in no way material or mechanical.

This is done by mechanical action on their smallest particles by means of friction and shaking, and by the addition of an indifferent substance, dry or liquid. This process is called dynamization; potentiation (development of healing power) and products are dynamizations or potencies in varying degrees. [Aphorism 269, 6th ed., Organon of Medicine]

Fortification is not only a process of dilution that releases the dynamic properties of the drug, but friction with an inert vehicle, a process of suction or trituration. So it is dilution plus friction that releases the pharmacodynamic properties of the drug.

### **SUBJECTS / BENEFITS OF POTENTIATION**

1. The continuous process of reducing the substance amount of the drug prevents unnecessary deterioration of drugs and side effects of raw materials.

2. Medicinal properties which are latent in the raw state are awakened and roused to activity.

3. Substances which are poisonous or toxic in their raw state, such as caustic acids, poisons, heavy metals, poisons, etc., become important beneficial drugs after potentiation.

4. Substances that are medically inert in their raw state can be activated after potentiation.

6. Potentiation helps to bring out the special "individualistic" properties of the drug, which helps in selecting similimum based on the similarity of these special individualistic symptoms.

### **HISTORY OF POTENTIATION**

The principle of drug dynamization succeeded in proving drugs and in stating the law of the like, and was the third step in the development of homeopathic principles.

Hahnemann began experiments with the application of proven drugs to cure the sick based on the law of similars, using drugs in their full strength. He found that the patient had gotten very bad many times. Hahnemann decided that the dose was too large and experimented with diluting the drug on a certain scale. To his surprise, he found that he secured better results. He continued this process until he found that the curative power of drugs was not proportional to the gross quantity, but that, under special and systematic reduction on a regular scale and properly handled, many drugs in common use and many substances supposed to be inert in their crude states, were endowed with new and hitherto unknown activities and powers.

Two closely related discoveries brought Hahnemann closer to the principle of dynamization -

1. One of them was an improved therapeutic effect by reducing the dosage of previously used drugs.
2. Another finding was that substances such as salt or lycopodium, which were not previously identified as drugs, became therapeutically active after this process.

1790 – 1796: Essay in Hufeland's Diary

1798 – 1811: Prescribed medicines in usual doses but slightly reducing doses. By this time, it was recommended to reduce the dose in order to prevent the violent effect of the drug. No mention in the *Medicine of Experience* (1805) and Volume 1 of the *Organon of Medicine* (1810).

Hahnemann gradually increased the dilution of the drugs. Around 1825, Hahnemann came to view these preparations as "dynamizing" or "optimizing" rather than mere dilution.

It was at this stage that he understood the idea of friction as causing a remarkable change in the activity of the drug. This is shown in his article "How Small Doses of Medicines So Very Weakened as Homeopathy Uses Can Still Have Great Power" in 1827.

Hahnemann felt in 1829 the necessity of a limit in potency and declared the final degree of dilution to be the 30th centesimal potency.

In the 5th edition of the *Organon*, Hahnemann clearly described the concept of potentiation in §269. He gave the first specific instructions for dynamization in §270-271.

He then developed the Fifty Millesimal scale and described it in the 6th edition of the *Organon* (§270).

## **DILUTIONS AND STRENGTHS**

A solution of a salty or bitter substance loses its flavor more and more as more water is added, and eventually has almost no flavor, no matter how much it is diluted and shaken. Thus also the dye solution, by mixing more and more water, finally becomes almost colorless, and any shaking does not increase its color.

Dilutions exist almost exclusively in matters of taste and color. They are and continue to be mere dilutions, not dynamisms.

Medicines are potentiated in two ways:

Trituration - in the case of insoluble substances

Suction - in the case of soluble substances

The goals of potentiation in homeopathy are:

Reducing the amount of the medicinal substance, which helps prevent unwanted deterioration and side effects.

Homeopathy believes that the vital force is dynamic in nature and that affected by disease, it can only be cured by the dynamic force of applicable medicine, not by its material quantity.

By this process the most virulent and deadly poisons are not only neutralized, but converted into beneficial remedies.

Substances that are medically inert in their raw natural state thus become active and effective for treating the sick.

The healing properties of other drugs, which are more or less active in their natural state, are enhanced by this process and their field of action is expanded.

## **THE DYNAMIC ACTION OF MEDICINES HAS BEEN DETAILED IN THE FOLLOWING APHORISMS WITH EXAMPLES.**

Dynamic Action:

Dynamic action refers to the immaterial, invisible, energetic action of one substance on another substance, the technical know-how of which cannot be explained, but its effects are perceived. "What happens" can be observed, "why it happens" and may not be explained, but "how it happens" certainly cannot be seen.

For example, a magnet attracts a piece of iron, but you can't see how it's done. This invisible magnet energy does not require mechanical (material) aids, a hook or a lever, to attract the iron. A magnet attracts to itself and to a piece of iron by means of a purely immaterial, invisible, conceptual, inherent energy which is dynamic (F.N.S. 11 - Sixth Edition). Similarly, the vital force (dynamis), the energy that animates the material body, acts by its dynamic action to express its various living manifestations.

Effects of medication(s):

Medicines are able to change the health status of a living organism. Such ability is caused by the following two types of actions (Chapter 63):

a) Primary action

b) Secondary action

Primary action:

The primary action is the first action of the drugs on the vital force. It can also be defined as the first phase of the biphasic action of drugs

In paragraph 63 of the Organon of Medicine, Hahnemann says: "Every agent that acts on vitality, every drug, more or less impairs the vital force and causes some change in the health of the individual for a longer or shorter period. This is called primary action."

In section 112 of the Organon of Medicine, Hahnemann writes: — ...the primary action is the right action is the right action of medicines on the vital force.

When a drug is administered to a living organism, it primarily disrupts the vital force and produces unpleasant sensations and functions that are exfoliated outward through the material body as abnormal signs and symptoms. This action is called the primary action. Thus, the primary effect or first effect of a drug consists of the immediate changes that this drug produces on the organism.

During the primary action of the drug the vital force plays a passive or receptive role and simply receives the impressions it produces. The vital force is forced to enable change and change in the organism. So we say that the primary action is the action of medicine on the vital force.

The primary effect of the medicine is a joint effect, because it is the product of the healing and vital forces together.

Secondary Action:

The automatic defensive reaction of the vital force against the primary action of the drug is called secondary action. It is the second phase of the drugs' biphasic action.

According to Hahnemann: "In its activity, our vital force tries to resist its own energy. This resisting action is a property, it is really an automatic action of our life-saving power, which is called secondary action or counter-action." (sec. 63)

## MODIFIED POTENTIATION TECHNIQUES

Many of Hahnemann's followers kept pace with the scientific and industrial revolution and began to construct labor-saving techniques and machines with which to prepare high potencies.

Hahnemann always spoke of trituration done by hand. It was practical and possible to prepare Hahnemann's potencies by hand, as he mostly used until the 30th century. But already during his lifetime attempts were made to modify his process.

There was a small group of Hahnemann's followers who used high potencies. Among these enthusiasts, Dr. Gross, Dr. Schreter and General Korsakoff of Russia. They became the real founders of the theory of high potencies.

## CONCLUSION

In Section 281, he says that he has made some changes in the procedure for the execution of inheritance. Hahnemann says: "...And furthermore, homeopathic medicines are potentiated by the very division and reduction by trituration and succession - by the development of the natural powers of medicinal substances, which before my time were not even dreamed of, and which has such a strong character as In recent years, I have been convincing experiences forced to reduce the 10 previously directed successions to two.

These are the findings of the study

1. The statistical scale used to evaluate the treatment effect showed a significant improvement after treatment. Out of 30 patients, more than half of the cases i.e. 25 patients showed significant improvement and 03 patients showed improvement within 7 months while treatment was discontinued in 02 cases.

2. Out of 30 cases, 25 cases [83%] were completely cured. 03 cases [10%] showed significant improvement after homeopathic treatment.

## Recommendation

1. A larger sample with extended research time using not only Robert's "Sensation as If" but also using Dr. Holcomb and Dr. Wards would give a better result.

2. Investigational studies, if conducted concurrently during the study, would provide evidence-based results.

The conclusion contains the scope and limitations of homeopathic medicines in the treatment of any kind of disease.

So the conclusions can only be:

Vital energy exists and is the only one that controls the function of the body.

It is based, like everything in this universe, precisely on natural laws and energy.

The concept of resonance clearly shows that every stimulus acts on the vital force and it can either adapt or respond to it without noticeable symptoms or with noticeable symptoms - according to whether the stimulus is stronger or weaker than the vital force itself.

Since the vital force can be thought of as an electromagnetic field based on energy, there is only one way to strengthen it, one real way of treatment: that is energy medicine.

Any other influence will only suppress the defense mechanism, the vital force, and increase susceptibility to influence even more.

The reason allopathic treatments sometimes accidentally "cure" is because certain drugs are actually "similar" to the disease they are treating, in the way that Ritalin (also known as "speed") is similar to ADHD.

He comes to the conclusion that the prognosis of the case is determined not only by the drug that should suit the patient, but also by the potency and dose.

It was concluded that one or two homeopathic potencies should not be adhered to, the choice of potency should be based on the patient's receptivity.

Repetition of the drug in the appropriate potency should be very careful.

The amazing fact is that when drugs are potentiated in this way, their medicinal properties increase in geometric progression as they are diluted! The higher potencies (actually more diluted!) are used with extreme caution in the system and are capable of greater penetration and are particularly useful in the treatment of long-standing chronic cases.

I come to the conclusion that even if there is no need for scientific proof of the effect of the drugs, when they treat the patient on a dynamic level.

## SUMMARY:

"In the healthy state of man, the spiritual vital force (autocracy), the dynamism that animates the material body (organism), rules indefinitely and maintains all parts of the organism in admirable, harmonious, vital operations. sensations and functions, so that our inner, rational mind may freely use this living, healthy instrument for the higher purposes of our existence." In short, there is a force within every living organism, a force capable of sustaining itself. This force is the driving force even the sustaining reason of its life. Which is invisible and immaterial, and is therefore sometimes called the simple substance. It manifests itself in sickness and in health, and rules the material body in which it resides. All the actions and functions of the material body are under its control and are brought about by that it is there. Any change in its composition will also be reflected in the material body. Diseases are nothing but a change in the individual's state of health, caused on the contrary by any changes in his vital force, which manifest themselves in the so-called signs and symptoms.

According to him, homeopathic dynamization are processes during which the healing properties that are latent in natural substances (in their raw state) are awakened and then allow to act almost spiritually on our life principle. The product of dynamization is called potency.
