Reading: Users can read the book on their device, either online or offline.

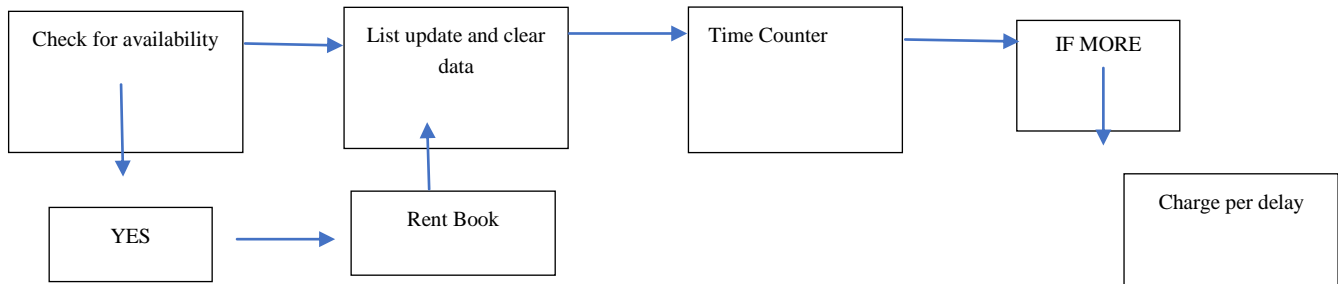
Return: When the user is finished with the book, they can return it either physically or digitally, and the app will update its records.
