5. **Asset Turnover Ratio:** The asset turnover ratio indicates improved efficiency in asset utilization, potentially influencing the company's financial health and share price positively.

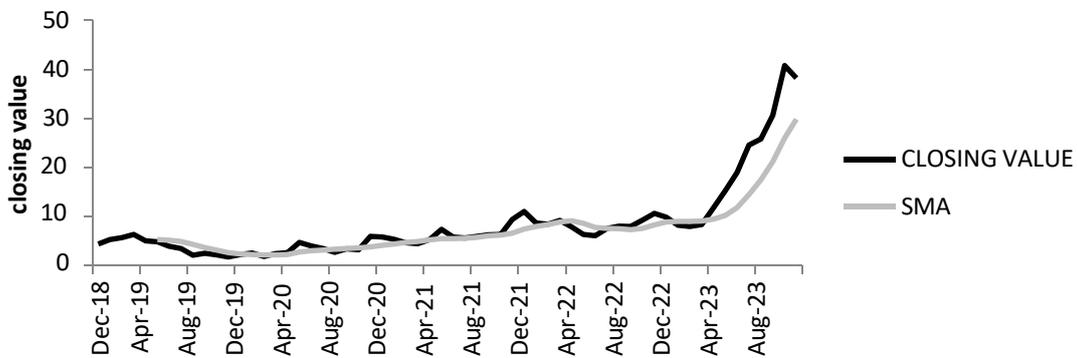

CLOSING VALUE AND SIMPLE MOVING AVERAGE (SMA) ANALYSIS:

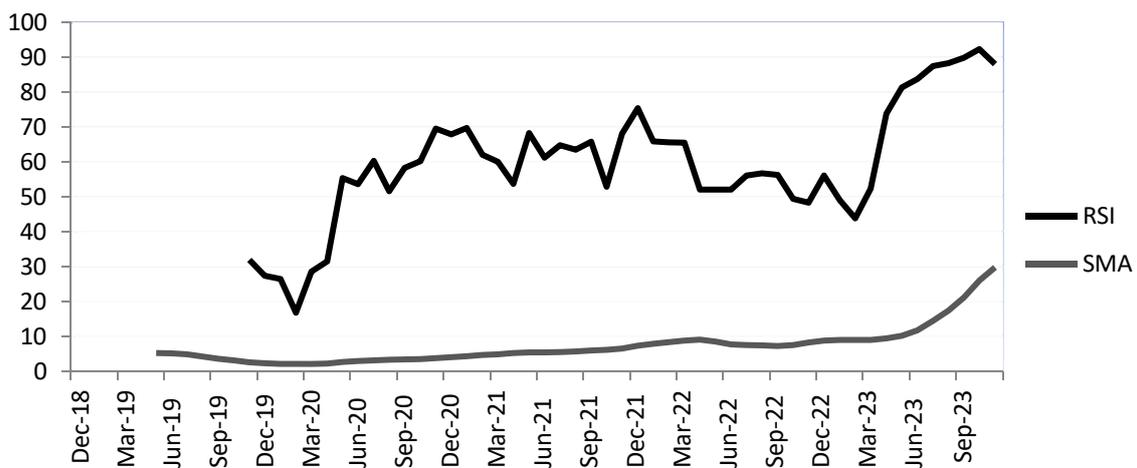
Chart 4.11 - SMA ANALYSIS
