A sound knowledge of anatomy permits homeopaths to connect with patients about their health issues in an engaging and understandable way.

Thus, integration of anatomy with homeopathic medicine in more emphasized way will be treating the individual as a whole and can collect more clinical data in particular direction. It will justify the statement that homeopathy is the mode of treatment with science and art.

Role of anatomy in Homeopathic Medicine :

The homeopathic medicines obtained from natural substances gaining the healing property after potentization. Potentization is a series of dilution of medicine with alcohol to enhance the inherent healing power of medicine. It helps in alignment of deranged vital force.

Vital force is the vital principal of the homeopathic philosophy and it is the dynamic energy that animates living organisms as well as maintains the vitality. Symptoms are the manifestation of the disturbed or imbalanced state of vital force. Integration of anatomical structures cell, tissues, organ, systems are responsible for the manifestation of disturbed vital force.

A patient come with knee complain such as, stiffness, pain and swelling may be benefited with a homeopathic medicine that has been used to address knee joint as well as its efficacy to resonate with the patient's symptomatology as a whole and anatomical disturbances.

However, homeopathic medicines are prescribed after individualizing and proper consideration of anatomy knowledge will play an important role to navigate the root cause of disease beyond specific organ system and helps in rearrangement of deranged vital force

The concept of "homeostasis' was given by a great Physiologist named Bradford Cannon. It is found the connection between of

Cannon's "homœostasis", and Hahnemann's principal of Vital Force. Cannon identified that adrenaline release is directly proportional to the level of stress. In the same way as per Hahnemann in psychosomatic disease disturbance at the emotional level (Part of limbic system of brain) leads to effect on body.

Thalamus is a relay station in with all information from body senses processed and then send the information to cerebral cortex. Eventually these informations are manifested as symptoms. Thus, through homeopathic perspective manifest as deranged vital force.

Role of Anatomy in clinical Practice :

During case-taking homeopaths conducts detailed clinical examination with help of sound knowledge of anatomy which enables them to tailored diagnosis and to differentiate similar medicines.

For example: A patient is complaining pain in right hypochondriac region, as well as pain on the tip of right shoulder along with other general symptoms. A sound knowledge of anatomy will help to assess that it could be due to Cholecystitis, as pain in the tip on right shoulder occurs due involvement of phrenic nerve (Root value C3, C4 & C5) and it has common innervations for gall bladder & tip of the shoulder. It may help in diagnosis the case as well as selecting similimum homeopathic remedy.

Discussion :

It has been observed that anatomy plays a very important role in homeopathy. It is very difficult to describe the homeopathic remedy *Lycopodium* without referring its seat in gut, involvement of biliary tree and localized in right side of the body. In homeopathic Materia Medica anatomy is limited to the as location of the disease. More research needs to be done at the level of drug proving and clinical verification and upgrade the level of integration of anatomy in homeopathy. In short anatomy knowledge needs to be more emphasized as it furnishes characteristic symptoms.
