### ABSTRACT:

Homeopathy is a gentle, painless, overall system of treatment developed during the 1790s by Samuel Hahnemann, a German physician. Using on herself with the malaria drug quinine, Hahnemann noticed that the large dose of the drug actually causes symptoms such as malaria, while the small doses cured the symptoms. From this, he advanced his concept of Similia Similibus Curentur, or let it recover with ".

Homeopathic physicians want to cure their patients at physical, mental and emotional levels, and each treatment corresponds to the individual needs of a patient. Homeopathy is generally a safe treatment, as it uses extremely thin amounts, and usually has minimal side effects. Its non-toxicity makes it a good choice for the treatment of children. Another benefit of homeopathy is the cost of treatment; Homeopathic remedies are inexpensive, often a fraction of the cost of traditional drugs.

Acute homeopathic prescription is considered to benefit many types of diseases. These include height disease, bell paralysis, common cold, allergies, cough, dengue fever, dysentery, ears, migraine headache, fever, food poisoning, grief, influenza, motion sickness, shock, sore throat, surgical complexities and response to vaccination and medication. Acute treatment can also be prescribed to treat problems related to insect stings, animal bites and poison oak and poison ivy. It can be employed further in the treatment of injuries including black eyes, irritation, injuries, contusions, cuts, damaged tendons and ligaments, sprains, fractures, herniated discs, nosebleeds, puncture wounds, sprains and stress.

From that time, mankind has to overcome many obstacles. And the man has always tried to detect the cause of diseases from Adam and Eve. Some of them are solved, some are unresolved. Health is one of the major factors in these unresolved incidents. Ways to restore Health are an evergreen question. Many methods have been prepared and abandoned since ancient times. But one of these treatments has proved its efficacy through age. This is homeopathy.

Credit goes to Hahnemann, after observing the discipline of the orthodox school of the German physician, who brought homeopathy from page to practice. Homeopathy is a branch of medical science which believes in the application of therapy that has the ability to produce the condition of the same disease. This principle of Similia is the origin of homeopathic treatment.

There is no royal rider to reach Similia. There are various methods and they are all useful in situations. From the time of Hahnemann, the homeopathic fraternity was dedicated to find out in a way, which to get the original of the disease from the mass of symptoms and to get the real picture. It is found in practice that the patient recalls his symptoms and explains which are not in the sequence, even meaningful and relevant. It becomes the duty of the physician to have maximum importance to lift a correct symptom, by a systematic way by which the picture of the disease becomes very clear to provide the maximum possibility of matching with that symptom spectrum, as the material is noted in the medica with the area of action. This process of detecting those important and meaningful symptoms is called evaluation.

### INTRODUCTION:

The word posology originates from Greek words, which means 'how much' and 'logo' meaning 'study'. In homeopathy, posology means the principle of dose dose. A homeopathic dose means recurrence with the power, volume and form of the drug. As it is a very long theme to find out, I will just focus on the potency selection part of Posology.

Rajan Shankaran writes: "The selection of potency depends on the intensity, clarity and ease of the symptoms expressed - especially peculiar symptoms, which reflect the personality of the person.

Even during the life of Hahnemann, there was a division between homeopath. A section believed in the use of powerful remedies and believed in raw doses based on another Simila. Most of those who used powerful treatment were not in favor of very high power. During the years after Hahnemann, supporters of raw doses decreased and high strength was more used.

It is always said that one ounce of prevention is better, one pound is better than treatment. Day.

All revolutions in the world originate in the minds of some individuals, who appear in psychological moments and declare their missions. Whenever a revolution begins, he is associated with his opponents, the opponents who try to destroy the new revolution, or try to turn it.

"Your patient's degree of sensitivity also affects potency selection. Some individuals are over-sensitive (often due to inappropriate homeopathic treatment) and they will prove any remedy you give them; they require them, therefore, medium or low power. A third type of patient is a third type of patient where the significant force can be easily enhanced. Idiosyncrasy must be present or not enough to be enough to be presented to the patient for a measure. Where it is extreme, low or moderate power should be preferred, where patients are habitually poisoned by a raw substance, as a general rule it advises to give that substance to very high power, it is better to give an antidotal substance.

## REVIEW OF LITERATURE:

To understand the homeopathic prescription, it is necessary to differentiate between acute and chronic disease. The acute disease is characterized by an latent duration, a duration of intensity, and a period of decline. The chronic disease, by contrast, is the duration of progress, but there is no fall, and there is no tendency towards recovery without proper treatment.

Acute homeopathic prescription is the part of homeopathy that treats the disease that suddenly starts and requires immediate attention. In homeopathic therapy, the intense mainly refers to the onset of disorder and the speed of a self-limited character rather than its severity. Colds, influenza, sore throat, insect stings, cuts, injuries, vomiting, diarrhea, fever, muscle pain, and short-term insomnia are examples of all conditions that are treated by acute prescription. The purpose of measures given in acute homeopathic prescription is to stimulate the internal capacity of the body to cure itself; They do not kill germs or suppress symptoms. Acute prescription - Patients can be done by patients at home as well as homeopathic physicians. Study courses, self-healing guides, and homeopathic home medicine kits are now available by reconciliation with homeopathic pharmacies and educational services.

Intense tips are less complex than older people. Homeopaths should first dismiss the possibility that acute symptoms represent a chronic problem (which may occur often). She then compiles a complete "symptomatic picture" that is made up of their form (makes the conditions better or worse), their locations, extensions and clear symptoms with sensations. Mental/emotional symptoms, if prominent, is used for different measures.

Homeopathic classification of symptoms

Homeopathic physicians use word symptoms in more inclusive fashion than traditional medicine. In homeopathy, the symptoms include any change that experiences the patient during the disease, including changes in emotional or mental patterns.

Homeopaths classify the symptoms according to the hierarchy of four categories for the purposes of acute prescription:

- Penching symptoms. These are people who are unique to the person who do not occur in most individuals with acute disease. Homeopaths pay attention to strange symptoms because they often help determine the remedy.
- Mental and emotional symptoms. These are important common symptoms that inform homeopaths about the total experience of the patient's disorder.
- Other common symptoms. These are physical symptoms felt throughout the patient's body, such as fatigue, changes in appetite, or restlessness.
- Special symptoms. Special symptoms are localized in the body; These include symptoms like nausea, skin rashes, headache, etc.
- During the homeopathic case-carry, the physician will evaluate the intensity of the symptoms of the patient, assess their depth within the patient's body, pay attention to any strange symptoms, evaluate each symptom methods, and make a list of major symptoms to direct the selection of proper therapy.

## Case to take a case

The first step in acute prescription is a long interview with the patient, known as case-taking. Keeping in mind the character, location and severity of the symptoms of the patient, homeopath will ask about their form. Turus are the conditions or factors (eg, A/F weather, day time, body conditions, behavior or activity, etc.) that makes the symptoms better or worse.

Case-taking can also be done by patient or family member as well as homeopath.

Selection and administration of a remedy

The option of a specific measure is directed by the patient's total symptom profile instead of the disease. Homeopathic remedies are determined according to the law of equality, which believes that in healthy people, specific symptoms cause those symptoms in sick people when highly thin forms are given. For example, a patient with influenza who is irritable, headache, and suffering from joint or muscle pain, is likely to be given bryonia (wild hops), as this plant extract will cause this symptom cluster in a healthy person.

Acute prescript therapist should be able to take the case properly, he should have knowledge of the disease, remedy (both should be able to detect PQRS), the knowledge of the measure applied to disease knowledge and knowledge of many more things mentioned in the next part of the literature.

Acute disease

The disease is an abnormally converted state of life, where spiritual, automatic dynamic vital force is mainly deranged by dynamically sick dynamic effects, leading to inconsistent sensations for life and irregular function, which are externally illuminated through the physical body as abnormal signs and symptoms (§ 11).

In the second word, the disease can be considered through sick symptoms and it is an externally reflective picture of the internal essence of the disease, that is, the affection of significant force (§ - 7).

Acute disease is the disease caused by the transient explosion of latent Psora for some exciting reasons: due to the following characteristics:

- sudden onset.
- rapid progress.
- Eliminate their cause more or more quickly.
- The duration of sorrow is fixed and is always moderate.
- Without medication, in recovery or in death, either eliminates itself.

Heniman defines the condition of acute disease, 'rapidly sick processes of unusually deranged vital force, which have a tendency to eliminate their cause more or more quickly, but always in a moderate time. They are called acute disease'.

H.A. Roberts, 'important tasks in acute expression are often restored through their power and to complete the harmony through it.'

- Exciting reason int latent psora
- Transient explosion
- Rapid illness.

Her Queen Dr. from Homeopathy's Bible. Henimain has given us direction to deal with acute states. They have told us the classification of the disease, the cause of the disease season, acute or chronic. Let us see what they have said about the disease in APHORISM 71, 72, 73.

The disease for which man is responsible is a rapidly sick process of unusually deranged vital force, which is a tendency to reduce its course more quickly, but always in moderate time - these are called acute disease (§ -72).

In the last lines of Aphorism number 73, Dr. Henimain has said that there are acute Miasms that recur in the same way, who either attack individuals, but once lifetime, in the form of measles, measles, which is the ancient, smooth, bright red scarlet fever of the scene, etc.

These lines again Dr. Henimain's highly fertile mind is proof, in which he has explained our body's immune system. In the chapter of immunity in which we study that during the early years of life, the immune system is in the process of obtaining lessons from infection. Any infection that enters the human body goes into circulation; This infection is nothing but antigen from microorganisms. This antigen triggers the immune system, conducting immune function, it tries to understand the nature of the antigen so that it can produce its equivalent which is antibodies. Thus the immune system takes time to understand about antigens during its first invasion in the body. But once it produces antibodies, the era of antigen ends.

The risk of the immune system for antigen gives two benefits to the person, to produce antibodies and to neutralize the poison of antigen and the second, some of these antigens do not go into the memory of the antibody reaction immune tool, as the body is exposed without a similar type of transition in future, changes in body harmony.

Thus we see that some disease due to the memory of the immune system, some disease once on a person and the final eg. Small pox, measles etc.

While diseases such as Asian cholera and plague cause antibody reactions, but fail to register in memory of the immune system, resulting in a person suffering from similar affection in his future, thus lying within the domain of the latent piece.

Thus from the above explanation we can draw a conclusion that acute disease is nothing but an outbreak of latent pieces and some of its outbreaks will be taken care of by the body's immune system, while some of them will require simileum to deal with this individual nature and disposal. An intense recipe of simileum is to be done, which sometimes has to follow by your old to break its old tendency.

#### Acute prescription

The current totality that includes the main grievances (s) and concomitant, under the four elements of each place, controls the choice of measures in sensations, modelity (IES) and compatible (s). The value of concomitant should be high in acute prescription, especially in physical disease mental concomitant, and physical concomitant in mental disorders (Kasad K. N., 2003).

In acute diseases, the patient's constitutional symptoms are thrown into the background, and the vital force under the influence of the environment brings the acute symptomatic to the forefront. Acute symptoms are adequately treated by acute remedies indicated after science, they disappear, and old constitutional symptoms first submerge, now re -appear at the end of acute disease. This is the best time to give indicated constitutional measures, which will prevent relaxes. If not given at this stage, then the disease will be saved.

- Intensified exaggeration of chronic disease:

There are two approaches to acute stages/attacks of chronic diseases.

Acute prescription based on current totality, and (b) Constitutional prescription in chronic diseases.

These diseases are an expression of incompatible immune response occurring as a result of sick sensitivity.

Acute episodes of periodic disorders:

These are a relaxing nature or chronic diseases of periodicity, with acute attacks or episodes. Acute paroxysm / episode requires acute prescription based on current totality.

- Constitutional prescription in acute diseases.

Sometimes, in acute illness, significant force is overwhelmed to the sick agent disqualified for life that it is not able to throw acute response, but in self-defense the generals have to call. Constitutional symptoms, instead of recurrence in the background, become prominent, and it asks for intensive acting constitutional measures.

- Unusual prescription:

On the occasion in acute diseases, in the absence of clear cut pointers for acute measures, in this case the following categories of treatment have to be resorted to (Kasad K. N., 2003) nosods organ treatment pathological prescription changes of remedy.

- Concept of fixed general totality (FGT) and sector totality (st):

In the development of acute disease, there is a generalized disturbance in the human economy due to deranged dynamic. It cannot be called as a disease and is not a disease, as no localization has occurred yet. This is the pre-localization phase of the disease process. As the disease progresses, various areas / areas are involved and it can be called disease where localization has occurred.

This localization of general disturbances may include any system. Once again the generalized disturbances in the human economy occurred with the affection of the normal sector. The first generalized disturbance manifests as a normal totality, thrown by the patient's constitution

and it is added to the area (s) later, with more or less fixed, stable, minor changes. Therefore, it is called a certain normal totality in relation to the variable sector totality, which is later thrown when affected.

- Self-care is recommended only for acute, self-limiting conditions, such as sometimes colds, simple headaches, abdominal pain, menstrual cramps, minor injuries and even emotional upset. In such cases you can quickly relieve this situation if you know how to choose the right solution. This is not easy and requires considerable study. Such infections with more complex and potentially severe acute emergency fever and all chronic disorders require expert knowledge and experience of a trained homeopathic businessman.
- *Aconitum napelus* - fear, fear; Sudden beginning of violent symptoms with fever after exposure to cold and dry air
- *Apis Melafa* \*\*\* - Bee, wasp, hornet, etc. sting; With pain, and red, puffy, shiny, warm swelling
- *Arnika Montana* - after the fall, such as decline, consumption, bumps, injuries, contradictions, car debris; To prevent shock from any injury; Emotional blow;
- *Arsenicum album* - cold, stuffed head, irritation from mucus and burning sensation in throat, better than hot drinks; With food poisoning, vomiting and diarrhea; Like eating bad meat.
- *Belladonna* - hot, dry forehead, glass eyes, thirsty-less high fever of sudden onset in children; Effects of sun stroke; Helps in killing adverse effects of rabies shot in animals
- *Bryonia alba* - sprains and injuries worse than speed, better than comfort and heat; Fever with great thirst for big sponges of colds, flu, cold drinks, pain on all pain, irritability
- *Calendula Officinalis* - the first intention treatment of wounds, cuts, tears, rupture of tissues, tendons and bones (orally in power); Anti-infective, antiseptic (slim tincture is applied directly to the wound)
- *Cantharis* - Burns and scalds, up to first or second degrees; Sunburn; Complaints with UTI or urinary burning pain
- Cellphones and cell mast-second-hand cell phones and other wireless technology to kill any effect after exposure
- *Hyperthymum perforatum* - fusion of head, neck, spine or tail; Shock; Injuries to nerve rich areas such as fingers, neck, waist, toes; To prevent tetanus arising from puncture wounds in the palm of the hand or the sole of the foot.
- *Heper sulfuris calcem-3* x-12x between potency (whatever we are), is used to kill mercury symptoms; Remove foreign objects like a splinter, etc. To antidote metal dust from aerosol spraying operation
- *Ladam Palusre* - insects and spider bites; Swelling and swelling with white swelling and cool to touch (swelling is usually warm to touch); To prevent tetanus caused by any wound
- *Rhus toxicodendron* \*\*\* - Poison Ivy, Oak and Sumac; Injuries for over-stringing, worse than pain, better than speed, worse at first speed (Crackly Gate); In case of heart attack as first aid.
- *Roota Gravalans* - (after the use of *Arnica*), muscles and tendons strains; eye strain; Parts are hurt; Injuries to periosteum (also consider *sympitum* and *calendula*)
- *Staphygia* - anger, resentment, afflicted; UTI; Injuries from a strong object like knife or scalpel (think about it after surgery)
- *Symphitum officinalis* - brakes and fractures; Injuries to periosteum; Eye painful injuries
- After the X-ray-Hawaii trip to the antidote radiation exposure, and to help neutralize any effect from solar flares, medical X-rays or much sun's risk.

Close gives the following ideas that affect the choice of dosage -

- The more and more symptoms of the drug in the case, the greater the sensitivity to the remedy will require more and greater power.
- Age: Moderate and high strength for children
- High power for sensitive, intelligent persons.
- Those who come in contact with high strength and enthusiasm or continuous effect of drugs for individuals of intellectual or sedentary business.
- Raw drugs may be required even under terminal conditions
- He also writes that "different powers do different work in different cases and in different cases, separate -time persons are required at different time. All can be required. All can be required. Any power, high or low, will meet the need for all matters all the time."
- Curie said that less dilutions are to be preferred in acute diseases, but in chronic diseases, high dilutions promise more and more success.
- Edgar successfully treated cases for twenty five years with low dilutions and mother tincture.
- Gentry feels that progressive diseases such as fever and infectious, treatment should be given in moderate or low power.
- Blackie reports that a high strength in cases of actual organic changes due to infectious can clean them.
- Grauvogl calculates certain rules for the use of power. He writes -

If we have to work on single parts, against single qualitative reason, we were better used for less dilutions, such as in Hemorrhage before or after the child's birth.

- With high strength, symptoms quietly leave no scars.
- In dealing with changes in the process of deficiency or oxidation or vice versa, we should use less dilutions.
- But to dissolve the process of retention, high strength is indicated.
- Nutrients function well in less dilutions, functional treatment in high dilutions.
- A chronic case, esp., When a carbo-nitrogenoid is based on retention in the constitution, the best can be corrected by high strength.

## CONCLUSION:

Acute diseases are due to transient explosion of latent psora, by some exciting cause. These diseases have sudden onset, rapid process and finished their course more or less quickly. Acute diseases may finish their own course and if not, application of similimum will remove the disease in its whole extent.

Disease is nothing but "alteration in the state of health of the individual, which express themselves outwardly by perceptible signs & symptoms." Therapeutically these abnormal signs and symptoms together constitute the totality of symptoms which indicate the similimum.

Dr. Hahnemann observed that the disease to which many are susceptible, are either rapid morbid process (acute) or insidious process (chronic diseases). Acute diseases are due to transient explosion of latent psora, by some toxic course.

Out of the 30 cases which were evaluated, 17 cases were cured within 72 hours while 13 cases showed good response (more than 70% improvement within 72 hours). In none of the 30 cases, was there any recurrence of symptoms. Neither was there any acute complication. Total time duration required for complete eradication of symptoms was greatly reduced with the help of Homoeopathic medicines. In cases 5, 12, 15, 16 and 21 respectively, where lower potency failed to act, high potency hastened cure. Statistical analysis also shows that there is great difference in scores before treatment and after treatment.

Therefore, according to the 30 cases I have studied, I can say that high potencies are very much useful in treatment of acute cases. This inference is not only for statistical purpose but it gives us guidelines for prescribing in acute cases. If we prescribe high potency in acute cases, we are sure to succeed in at least 9 out of 10 cases. This will give us consistent results in acute cases. This will then be a feather in cap for Homoeopathy. This will also make people get over the myth that Homoeopathy takes very long to act and has little or no role in treating acute cases.
